- 1 Current payroll period (month/year)
- 2 Contact to payroll office
- 3 Salary
 - Salary according to the current list of salaries as fixed by the state and trade unions.
- 4 Additional covers / capital-forming benefits
- 5 Total
- 6 Gross salary
- 7 Gross for health insurance / long-term care insurance
- 8 Gross for state pension insurance
- 9 Gross for unemployment insurance
- 10 Income Tax
 - The percentage of income tax is linked to your gross income, your tax bracket and other factors, and varies between 11 and 50%.
- 11 Solidarity tax
- 12 Church membership tax
- 13 Health insurance
 - Health insurance is mandatory and is paid by the employer and by you. This amount shows your contribution.
- 14 Pension insurance
 - Pension insurance is mandatory and is paid by the employer and by you. This amount shows your contribution.
- 15 Unemployment insurance
 - Unemployment insurance is mandatory and is paid by the employer and by you. This amount shows your contribution. Unemployment benefits are available if you are out of work. Payment depends on years of contribution and residence status.
- 16 Long-term care insurance
 - Long-term care insurance is mandatory and paid by the employer and by you. It is linked to your health insurance.
- 17 Statutory net salary
- 18 Employee's contribution to extra pension insurance
 - Shows the employee's contribution to the extra pension insurance (only applicable if you have not opted out).
- 19 Total sum / Transfer / Bank details
- 20 Monthly amount
- 21 Annual total amount

- A Personal Data
 - A1 Your personnel number
 - A2 Start of work contract
- B Tariff / Salary
 - B1 Salary group and subgroup
 - Salary group and subgroup according to your qualification and previous work experience. After a few years, you automatically reach a higher subgroup.
 - B2 Working hours per week
- C Control data / Tax Features
 - C1 Tax identification number
 - C2 Tax bracket
 - Depends on your marital status and/or on your spouse's tax bracket. Bracket I is for single persons, brackets III/IV/V are available for married persons. Bracket VI should be avoided.
 - C3 Religion (church membership)
 - Members of the Roman Catholic Church or the Protestant Church pay church tax, which is taken directly from the salary and passed on to the respective Church organization. The information about religious affiliation is voluntary and is noted down during the registration at the city hall.
 - C4 Child tax credit
 - Guarantees that a certain amount of your income is not taxed but available as living expenses for your child(ren).
