Duration of storage of personal data/criteria for determining the duration

We will store your data until the submission deadline of the Marie Skłodowska-Curie Actions Postdoctoral Fellowships on September 10, 2025, but for no longer than 12 months.

No automated decision-making (including profiling)

Your personal data will not be processed for the purpose of automated decision-making (including profiling) in accordance with Art. 22 (1) GDPR.

Right to withdraw consent

You have the right to withdraw your consent at any time to the named contact person for the future, unless the data has already been anonymized. This does not affect the lawfulness of the data processing carried out on the basis of the consent until the revocation.

Your further rights

You can exercise the following rights at any time vis-à-vis the contact person named above or our data protection officer:

- Erasure of personal data concerning you, provided that the requirements for erasure are met
- Restriction of data processing if we are not yet allowed to delete your data due to legal obligations,
